By executing this Authorization for Entry Onto Property and Hold Harmless Agreement in the space below, you are authorizing ACS&R to enter your property for the expressed purpose of moving trucks, vehicles, containers, and equipment onto or off of your property.

In addition, by signing below, you, your heirs and assigns, agree to hold harmless ACS&R and release its' owner and its' employees from any liability from any and all claims, liabilities (including injuries or death) resulting from placement or movement of refuse containers, causes of action, actions, expenses (including attorneys' fees), and damages to property resulting from or arising out of the weight and/or movement of ACS&R trucks and equipment on your property.

ACS&R has notified you that the movement of our trucks, vehicles, containers and equipment onto or off of your property may cause damage to the property due to the weight and/or movement of the trucks, vehicles, containers and equipment. By signing below, you assume the risk of all dangerous conditions regarding the refuse containers and waive any and all specific notice of the existence of such conditions. ACS&R has also notified you that it may not legally enter your property without your expressed written permission.

For purposes of this Authorization, the term "property" is defined to include your driveway, any structures and surrounding areas.

Waste Deposit Disclosure Statement 01/2018

Dear Valued Customer,

The Waste Management Act, as amended in 1993, requires that a person who collects construction debris, industrial waste, or mixed municipal solid waste for transportation to a waste facility shall disclose the destination of your waste.

In addition, the Minnesota Legislature requires Minnesota haulers to make the following disclosure to their customers; "You may be responsible for any liability that results from contamination at a facility where your waste has been deposited. Minnesota believes that its' waste management system provides substantially more financial and environmental protection than depositing waste in landfills in other states. Managing your waste in Minnesota may minimize your potential liability."

Pursuant to Minnesota Statute 115A.9302, Alpha Container Services & Recycling hereby discloses that your solid waste will be delivered to one of the following facilities during the time period of January through December. If an additional facility becomes either a primary or secondary facility during this period, we will provide you with updated information within 30 days.
